RE - NOTIFICATION

Applications are invited for Special Recruitment from among qualified Ex-servicemen of Scheduled Tribe candidates of Kerala State for selection to the following post. Applications must be submitted online through the official website of the Commission after ONE TIME REGISTRATION. Candidates who have already registered can apply through their profile. The photo uploaded through One Time Registration should be the one taken after 31.12.2010. Name of the candidate and the date of the photograph taken should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of photograph taken.

- 1 **Name of Department** : Sainik Welfare
- 2 **Name of post** : Lower Division Clerk (SR for ST from Ex-servicemen only)
(Re-designated as Clerk as per GO(Ms)No.120/2013/(138)/Fin dated 04.03.2013.
- 3 **Scale of pay** : ₹ 9940-16580/-
- 4 **No. of Vacancy** : District wise
Kollam - (ST - 2)

Note: (i) *The above Vacancies are now in existence. The list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the above vacancies and also for the vacancies reported for Special Recruitment from Scheduled Tribes during the currency of the list.*

(ii) *The selection in pursuance of this notification will be made on a Revenue District basis subject to the Special conditions laid down in G.O (MS)No.154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List so prepared is not eligible for transfer to another District unless he/she completes five (5) years continuous service from the date of commencement of service in the former District. Even if, transfer is allowed after five (5) years, it will be subject to the rules in GO(P)No.5/13/P&ARD dated 6.02.2013. But as per GO(P)12/96/P&ARD dated 16.03.1996, the condition of 5 years service is not applicable for the transfer to the Districts of Idukki, Wayanad and Kasaragod. This concession will be available only for getting transfer into these districts, but not for getting transfer out of these districts and this concession will be granted only once in the career of a Government Servant. Candidates already in Government service, holding the post in any one District are restricted from applying for the same post in another District. But they can apply for higher posts when notified.*

(iii) *Candidates from the Ranked List for districtwise selection will be advised for appointment against the Head quarters vacancies also. As per the provision in G.O(Ms)154/71/PD dated 27.05.1971 appointment against the Headquarters vacancies will be started from*

Thiruvananthapuram District. Separate option need not be given for this.

(iv) All the posts in the Sainik Welfare Department are reserved for Ex-servicemen. The vacancies reported for the post from Sainik Welfare Department was notified in the Gazette dated 30.12.2010 as Category No.416/2010 and again in the Gazette dated 31.12.2014 as Category No.699/2014. But no candidate was found eligible to be selected for the post. Considering this as a special case it is decided to notify the post again.

5 Method of Appointment : Direct Recruitment
(Special Recruitment from among Ex-servicemen of Scheduled Tribes only).

Note:- *Applications received from non ST Ex-servicemen candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.*

6 Age : 18-50, Should have completed 18 yrs and should not have completed 50 yrs of age inclusive of the period of Military Service.
Only Candidates born between 02.01.1965 and 01.01.1997 (both dates included) are eligible to apply for this post. But in no case the maximum age limit shall exceed 50 (Fifty) years.

Note : *For details regarding age relaxation please see the General Conditions given in Part II of this Notification.*

7 Qualifications:

A pass in S.S.L.C. Examination or its equivalent qualification.

Note:1 *Part II Rule 10(a)ii of KS&SSR regarding qualification is applicable for this selection.*
2. *Only Ex-servicemen belonging to ST community are eligible to apply for this post.*

8 Mode of Submitting application:

Candidates must register as per 'ONE TIME REGISTRATION' with the official website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have already registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. No application fee is required. Candidates can view and have a printout of the details in the profile by clicking the link Registration Card. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of each application, the candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application once submitted is treated as provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for.

- 11** If a written Test/OMR Test is conducted as part of the selection, Admission Ticket of eligible candidates will be made available in the website of Kerala Public Service Commission. Candidates are instructed to download their Admission Ticket as per the instructions in the Website.
- 12** Paragraphs two, three and twenty five (except the conditions laid down in the Rule 3 (C) of Part II of the kerala State and Subordinate Service Rules) are not applicable to this selection.
- 13** Appointments are made on the basis of the rank secured in the ranked list of candidates prepared in pursuance of this notification subject to the conditions laid down in G.O.(P) No. 21/76/PD dated, 17.01.1976 and G.O.(P) No.25/94/GAD dated, 22.01.1994 allowing special reservations to Scheduled Tribes in accordance with the procedures made for this purpose from time to time and subject to the rules under sections 3(c), 17(a), 17(b) of Part II of Kerala State and Subordinate Service Rules, 1958.
