2. **Name of Post** : **Junior Lab Assistant**
3. **Scale of Pay** : **₹ 18000 - 41500-**
4. **Number of vacancy** : **2 (Two)**

6. **Age limit** : **18-36, only candidates born between 02/01/1981 and 01/01/1999 (both dates included) are eligible to apply for the post with usual relaxation to other backward communities and SC/ST candidates**

7. Qualifications:-

Pass in Pre- Degree/Plus Two Course or Equivalent Examinations with Physics, Chemistry and Biology as optional subjects/ VHSE (MLT)

NOTE: *Rule 10(a) ii of Part II of KS&SSR is applicable*

8. **Mode of submitting Application:-**Candidates must register as per 'ONE TIME REGISTRATION' system on the official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' before apply for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and

password. Candidates must click on the '**Apply Now**' button of the respective posts in the Notification Link to applying for a post. The Photograph uploaded should be one taken after 31.12.2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link **Registration Card** in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure the correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, Experience, Community, age etc. have to be produced as and when called for.

- b) If a Written/OMR/Online Test is conducted as part of this selection, Admission Ticket for eligible candidates will be made available in their Profile for One Time Registration and the date of downloading will be included in the Examination Calendar. Candidates can download Admission Ticket for 15 days from this date. Candidates who have downloaded the Admission Ticket will alone be permitted to attend the examination.
